I. THE REQUEST

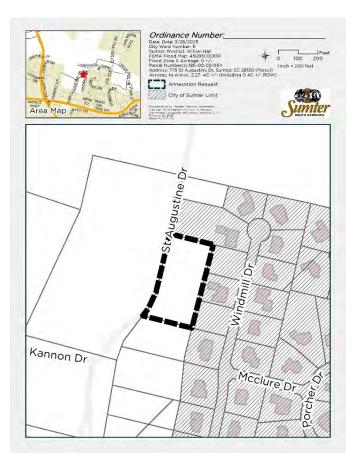

II. BACKGROUND

The applicant is requesting annexation for +/- 2.27 acres at 775 St. Augustine Dr. (herein referred to as the "subject property"). The subject property is further identified as TMS# 185-00-02-054. The applicant is requesting annexation via the 100% petition method. The subject property is contiguous to the City of Sumter jurisdiction to the north and east.

The subject property is located near St. Augustine Dr. and Windmill Dr. but is it not directly accessible by either. St. Augustine Dr. is a private dirt road and Windmill Dr. is a city owned and maintained public street within the Deerfield Subdivision.

The applicant also owns the adjacent +/-1.63-acre parcel (2755 Windmill Rd. - TMS# 185-05-01-020) located immediately to the north of the subject property. The Windmill Dr. property is

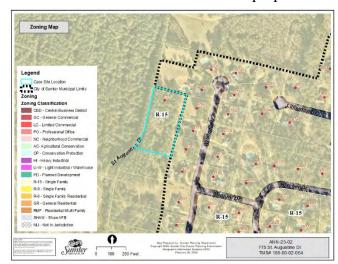


within city jurisdiction and is the location of the applicant's residence. Annexation is being

requested to allow the subject property to be legally combined with the 2755 Windmill Dr. property. This property combination cannot occur without annexation since these properties are

within separate political jurisdictions. The combination of these two properties is desired in order to extend the backyard of the 2755 Windmill Dr. property for home recreational purposes.

The subject property is currently zoned Residential-15 (R-15). The applicant is not requesting a zoning designation change at this time. Thus, unless otherwise initiated by City Council, the property will fall under the City R-15 zoning district if annexation is approved. In accordance with *Article 2.b.5* of the City of Sumter Zoning & Development Standards Ordinance, all



territory which may hereafter be granted or annexed to the City of Sumter shall be classified automatically in the zoning district in which it was previously zoned in the unincorporated portion of Sumter County unless the applicant or owner of the property requests and/or City Council designates a different zoning district. Any changes in zoning which emerge with annexation of property into the City must follow the standard rezoning process with a recommendation from the Planning Commission.

The property is shown as "Parcel D" on the plat recorded Plat Book 2015, Page 10 at the Sumter County Register of Deeds. This plat is attached to this report as <u>Exhibit 1</u> and is the reference map attachment to the formal executed petition.

III. FACTORS FOR CONSIDERATION

- 1. Land Use Compatibility: Per the City 2040 Comprehensive Plan, the property is within the Suburban Development Planning Area. The proposed use of the subject property, expansion of a single-family residential lot for home recreational use, is in alignment with applicable Comprehensive Plan policies and is consistent with the existing pattern of development in this area of the city.
- **2. Fiscal Impacts:** Most annexations represent cost increases to the City

for provision of public services such as Public Safety, Sanitation, and Public Utilities.

Increased costs are mitigated in part through property tax revenues, a portion of which go to the City. Public utilities costs are mitigated through user service fees that go toward ongoing system maintenance, operations, and capital costs.

City utility, sanitation, police, and fire services are currently provided to the adjacent property at 2755 Windmill Rd. It is the applicant's intent to combine the subject property with this adjacent property if annexation is approved.

In general, annexation of the subject property will not result in measurable fiscal impacts.

3. Growth Management: The property is directly contiguous to city jurisdiction to the east More broadly, the site is within a larger unincorporated area that is bounded by city jurisdiction on 2 sides. Annexation of this property is in alignment with growth management

principles, as it combines an inaccessible parcel with no public road frontage to an existing parcel that has public road frontage within a residential subdivision.

4. Public Utilities: If annexation is approved, the applicant intends to combine the subject property with adjacent property located at 2755 Windmill Dr. City utility and sanitation services are currently available to this adjacent property.



IV. STAFF RECOMMEDNATION

Staff recommends that the properties be annexed into the City. Annexation of any specific parcel is not an endorsement, in advance of review, for any specific development project or pending rezoning request.

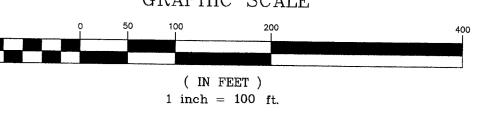

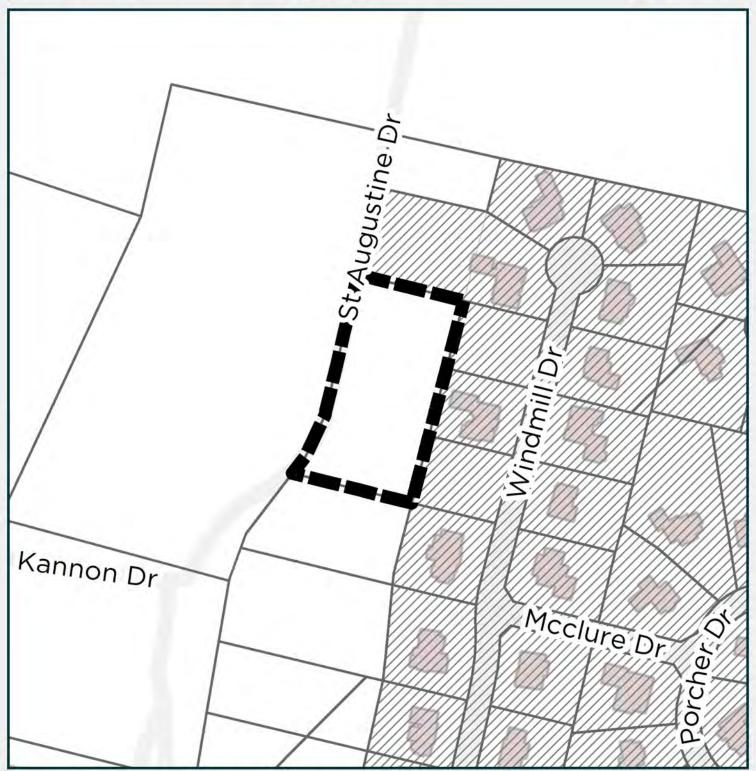
