Annexation Staff Report (ANN-25-03)

I. THE REQUEST

II. BACKGROUND

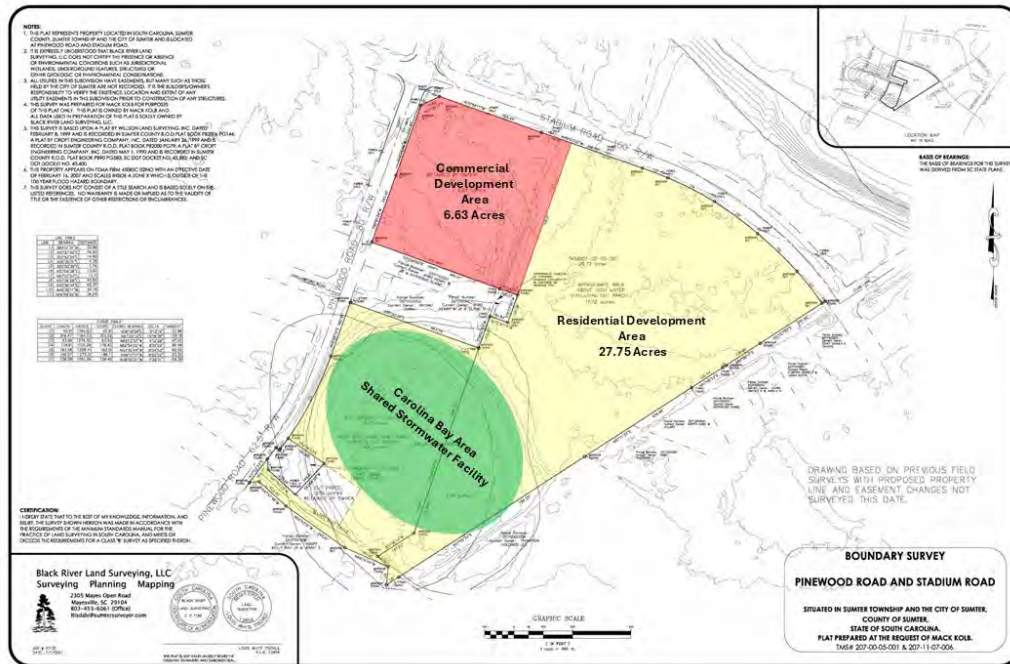
The applicant is requesting annexation for +/- 8.11-acres of property on Pinewood Rd. The property is located on the east side of Pinewood Rd. at the intersection of Pinewood Rd. & Shallowford Rd. The property represents a 7.65-acre portion of TMS# 207-11-07-006. The request also includes +/- 0.46-acres of adjacent SCDOT right-of-way (ROW) on Pinewood Rd. The total area for annexation, including adjacent street ROW, is +/- 8.11 -acres.

The property is directly contiguous to City of Sumter jurisdiction to the east. The property qualifies for the 100% petition annexation method.

The applicant is requesting annexation so that the property can be consolidated with the adjacent property at TMS# 207-00-05-001 as a cohesive Planned Development site



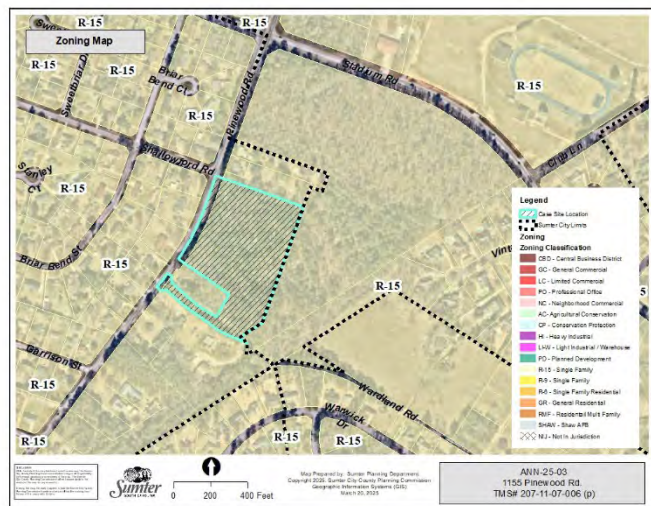
consisting of both commercial and residential development areas, as shown on the conceptual plan below:

The property is currently within the boundaries of the County Residential-15 (R-15) zoning district. The applicant has submitted a request to rezone the property to a Planned Development. This request is being considered via the standard rezoning process with a resulting recommendation from the Planning Commission. City Council will consider the Planned Development request after a final decision has been made on this annexation request

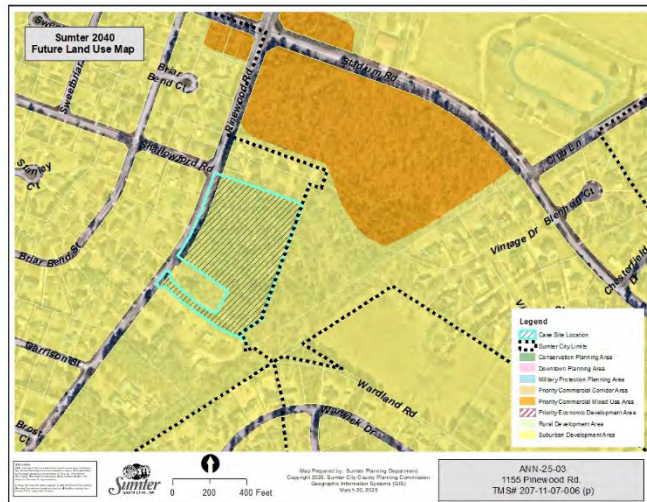
The property is a 7.65-acre portion of the (8.66-acre) portion of land described in the deed recorded at Deed Book 1022, Pages 1603-1606 at the Sumter County Register of Deeds. The property is also identified as the 7.65-acre portion of TMS#207-11-07-006 on the plat recorded at Plat Book 2025, Page 55 at the Sumter County Register of Deeds. This plat is attached to this report as Exhibit 1 and is the reference map attachment to the formal executed petition.



III. FACTORS FOR CONSIDERATION

1. **Land Use Compatibility:** This annexation request is consistent with the Sumter 2040 Comprehensive Plan. The property is influenced by the Suburban Development Planning Area and will be consolidated with a larger adjacent parcel that is primarily influenced by the Priority Commercial/Mixed Planning Area with the purposes of establishing a Planned Development with a commercial and residential component. The land area being considered for annexation is the intended location of the stormwater facilities and open space areas that will support the larger development primarily on the adjacent property, per the Planned Development conceptual plan submitted.

- **Suburban Development** – The primary goal of the Suburban Development Planning Area is to scrutinize and manage existing development patterns, foster intentional mixed-use development, and identify new commercial and industrial locations where form and design are a focus, all in a more efficient manner.



New development in the Suburban Planning Area is intended to be served by public utilities. The city supports the extension of public water and sewer within this Planning Area, consistent with applicable utility service boundaries and policies.

- **Priority Commercial/Mixed-Use**– The Priority Commercial/Mixed Use designation focuses on areas or nodes identified as future locations for high quality commercial and residential mixed-use development. Areas with this designation should be protected against undesirable uses such as industrial, automotive repair, or uses primarily engaged in outdoor storage. Destination retail uses and neighborhood commercial uses are encouraged within this designation, as appropriate. Design, layout, impact on adjacent properties, landscaping, and architecture all play a vital role in determining context viability.
2. **Fiscal Impacts:** All annexations increase the costs of providing public services such as public safety, sanitation, and public utilities. Increased costs are mitigated in part through property tax revenues, a portion of which is allocated to the city. Public utility costs are mitigated through user service fees that go toward ongoing system maintenance, operations, and capital costs.

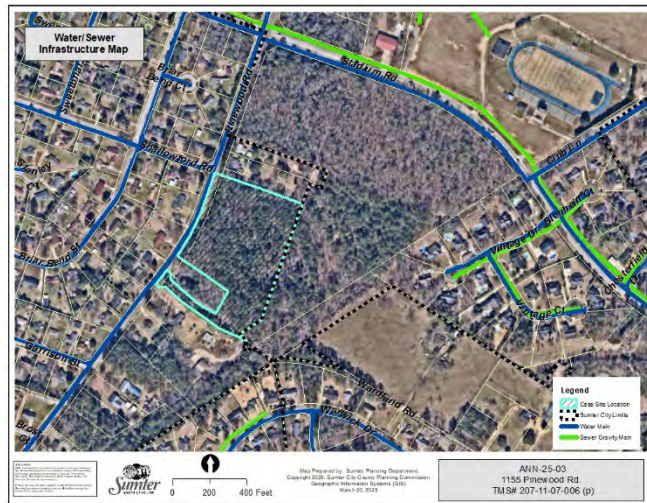
The land area being considered for annexation is the intended location of the stormwater facilities and open space areas that will support the larger development to be located on the

adjacent property already within city limits, per the Planned Development conceptual plan submitted. Any fiscal impact resulting from this annexation is anticipated to be minimal.

3. Growth Management: This annexation request is consistent with growth management principles for the reasons outlined below:

- a. The subject property is a critical component of a proposed Planned Development. The primary Planned Development area is already within city limits. Annexation will allow this currently unincorporated area to be regulated as part of a cohesive development plan. The annexation area is part of a Carolina Bay, thus it is environmentally sensitive. Having this area be a critical part of the stormwater facilities and open space of the larger development as part of the regulatory framework for the PD is beneficial for city growth management objectives.

4. Public Utilities: The property is in close proximity to existing city water main on Pinewood Rd. The closest sewer main is at the intersection of Pinewood Rd. and Stadium Rd. It is anticipated that the larger Planned Development area will be served from the water and sewer infrastructure available from Stadium Rd. Any cost to provide water and/or sewer service to the property will be the responsibility of the applicant. City Public Services will make the final determination on the city’s ability to provide service and/or the scope of the improvements required to provide service to the property.



IV. STAFF RECOMMENDATION

Staff recommends that the property be annexed into the city. Annexation of any specific parcel is not an endorsement, in advance of review, for any specific development project or pending rezoning request.

The undersigned, being 100 percent of the freeholders owning 100 percent of the assessed value of the property in the contiguous area described, respectfully petition the Mayor and City Council of the City of Sumter, pursuant to the provisions of Section 5-3-150(3) of the 1976 Code of Laws of South Carolina as amended by the cumulative supplements, for the purpose of declaring the area hereinafter described annexed to the City of Sumter.

The property is shown on the map attached hereto and is described as follows:

The property, identified as a portion of Sumter County Tax Map# 207-11-07-006 and located along Pinewood Rd. consists of 7.65 acres of property and +/- 0.46 acres of street right-of-way totaling +/- 8.11 acres to be annexed.

Said property is further described as being generally bounded to the **North** by land now or formerly of Sarah Bryant, further identified as Sumter County Tax Map# 207-11-07-003; generally bounded to the **East** by land now or formerly of Box Seat, LLC, further identified as Sumter County Tax Map# 207-00-05-001 (*refer to deed recorded at Deed Book: 1337, Pages 4907-4911 at the Sumter County Register of Deeds*), generally bounded to the **South** by land now or formerly of Kelly Ray Knopf, Jr. and Jenny S. Knopf, further identified as Sumter County Tax Map# 207-11-07-009; and generally bounded to the **West** by Pinewood Rd. right-of-way. Said property bounds the remaining 1.02 acre portion of Sumter County Tax Map# 207-11-07-006 that is not being annexed (*refer to plat recorded at Plat Book: 2025 Page: 54 at the Sumter County Register of Deeds*) to the north, east, and south.

This being the same property referred to as the portion of TMS# 207-11-07-006 containing 7.65 acres, more or less, as described in Deed Book 1337, Pages 497-4911 recorded at the Sumter County Register of Deeds. This also being the same 7.65 acre area shown on the plat prepared by Black River Land Surveying, LLC, dated July 1, 2021 and revised March 4, 2025 that is recorded at the Sumter County Register of Deeds in Plat Book 2025, Page 55.

Declaring the land hereinafter described annexed into the City of Sumter, pursuant to provisions of Section 5-3-150 of the Code of Laws of the State of South Carolina, and simultaneously granting zoning classification in accordance with Article II, Section "2.b.5" of the City of Sumter Zoning and Development Standards Ordinance

After due consideration, the Sumter City Council has examined the petition of the property owner for the annexation of the property hereinafter described, including all highway rights-of-ways, and have reached the conclusion that the petition is proper and should be granted.
