

II. BACKGROUND

This is a request to rezone a +/- 0.15-acre parcel (TMS# 250-09-04-025) from General Commercial (GC) to General Residential (GR).

The subject property is shown in red on the location map to the right. The property is located at the corner of S. Lafayette Dr. and Royal Ave, which gives the property two public road frontages. The subject property is currently undeveloped.

The applicant is requesting a rezoning of the property to General Residential (GR) in



order to place a manufactured home on the site. Manufactured homes are not permitted in the GC zoning district. Thus, rezoning the property to a district that permits manufactured homes is necessary for the applicant to move forward as desired. Manufactured homes are permitted in the GR zoning district.




It is noted that the east side of S. Lafayette Dr. in the general area of the property is primarily undeveloped or used for residential purposes, while the west side of S. Lafayette Dr. is primarily commercial in nature.

Zoning

The property is currently zoned GC. Adjacent property to the immediate north, south, and west is zoned GC. Adjacent property to the immediate east is zoned GR.

The purpose of the GC zoning district is to accommodate the broadest possible range of commercial uses, determined principally by market conditions, while protecting the environment from potentially objectionable uses.

The purpose of the GR zoning district is to accommodate higher density residential development and a variety of housing types



on small lots. This district is primarily intended to support the provision of housing in older,


established areas of the city. It is not intended to support new large acreage residential tract development.

An applicant is not limited by their stated use of the subject property. If rezoned, the applicant could establish any use allowed in the GR district subject to compliance with all required standards. See attached *Exhibit 1 - Use Table* for the full range of land uses permitted "by right", via conditional use approval, or via special exception approval.

III. COMPATIBILITY WITH THE 2040 COMPREHENSIVE PLAN

The Sumter 2040 Comprehensive Plan shows that the property is influenced by the Priority Commercial Corridor Planning Area.

The Priority Commercial Corridor Planning Area focuses on existing corridors throughout the city. These corridors have been host to a diversity of uses from large, destination retail uses to more base industrial outdoor storage uses. Many corridors with this designation are trending toward higher levels of vacancy, or marginalization of retail uses. They are visually uninviting and face outright abandons



visually uninviting and face outright abandonment.

Rezoning a single parcel along a major commercial corridor to a small lot residential district conflicts with the intent of Priority Commercial Corridor area policies.

IV. TRANSPORTATION REVIEW

The site has direct frontage onto S. Lafayette Dr. (US-15), an SCDOT owned/maintained roadway. The segment of S. Lafayette Dr. directly in front of the subject property is a paved 5-lane section (2 travel lanes in each direction and a center median/turn lane) that is functionally classified as a principal arterial roadway. Per SCDOT traffic count data from Station ID# 43-0111, the annual average number of daily trips on S. Lafayette Dr. near the subject property was 13,800 in 2024.

V. STAFF RECOMMENDATION

The subject property is located within a Priority Commercial Corridor, as designated by the 2040 Plan. This area is primarily intended for commercial development and redevelopment. As such, the proposed rezoning to General Residential (GR) is not consistent with the long-term land use goals outlined in the Comprehensive Plan. Additionally, rezoning the property to GR would significantly impact the adjacent GC zoned parcel to the north, as more restrictive setback requirements would make commercial development on this property unfeasible without variance relief from the Zoning Board of Appeals.

Staff recommends denial of this request.






