SUBJECT: Bar Screen Purchase

The Wastewater Department recommends the purchase of one (1) new Model FT-48 Mensch Severe Duty Bar Screen from Vulcan Industries, LLC to replace the existing, inoperable unit at the Pocotaligo Wastewater Treatment Plant. The quoted total cost for the screen assembly and startup services is \$235,596.

The bar screen is a critical component of the plant's preliminary treatment process, responsible for removing large solids and debris to protect downstream equipment. The current unit, which has served reliably for approximately 25 years, has exceeded its industry-standard life expectancy of 20 years and is now compromised and non-functional. The **lead time for delivery** is estimated at 40–48 weeks, making timely approval and procurement essential.

Given the urgency, proven reliability of Vulcan Industries' equipment, and the strategic importance of maintaining uninterrupted wastewater treatment operations, I strongly recommend that the **City of Sumter proceed with the purchase** of the FT-48 Mensch Severe Duty Bar Screen.

Project Description:

Vulcan Industries LLC is proposing to furnish one (1) new Model FT-48 Mensch Severe Duty replacement screen in kind to replace the existing Vulcan FT-48 Mensch Screen, Factory #3727 at the Pocotaligo WWTP.

The existing channel is 4'-0" wide by 6'-6" deep (total depth invert to operating floor level: 19'-0"). The screen shall be designed to handle a peak flow of 24.0 MGD per original design data. The new screen installation will be appropriate for the hydraulics present at the wastewater facility. Additionally, the new screen frame and dimensions are consistent with existing screen.

One (1) New FT-48 Mensch Severe-Duty Bar Screen:

The Mensch is a severe-duty reciprocating type (i.e. climber type) bar screen that is the industry's most robust and longest lasting screen. Vulcan has been manufacturing this screen, with continuous design improvements, for over 30+ years with over 1,500 installations. The reciprocating type bar screen allows for capture and retrieval of objects ranging in size from a tire to a pile of grit.
