

#### II. BACKGROUND

This is a request to rezone two parcels totaling +/- 1.85-acres (TMS# 202-00-03-014 + 202-00-03-021) from Agricultural Conservation (AC) to Residential-6 (R-6).

The subject property is shown in red on the location map to the right. The property is located on the east side of Camden Highway and is situated between Barnhart Drive and Minna Place.



The property identified by TMS#202-00-03-014 is currently developed with a residential home. The property identified by TMS# 202-00-03-021 is currently undeveloped and is a former portion of Minna Pl. right-of-way that was conveyed to prior owners of the subject property by SCDOT.




The subject property has received final reading approval by City Council for annexation of the property on June 17, 2025. The applicant intends to incorporate the property into the Bradford Meadows Subdivision for the development of three (3) new residential lots in accordance with R-6 requirements that will have direct access onto Barnhardt Dr. in addition to the creation of six (6) single-family attached lots that will front on and have access to Minna Pl. the original dwelling on the property will be retained on Camden Hwy. If successful rezoned this property, per the applicants proposal, will accommodate up to 10 dwellings, including the existing structure.

#### **Zoning**

The properties are currently zoned Agricultural Conservation (AC). Property to the north and east is zoned General Commercial (GC) and Residential-6 (R-6). Property to the west, across Camden Hwy., is zoned General Commercial (GC). Property to the south is zoned Agricultural Conservation (AC).

The purpose of the current zoning district Agricultural Conservation (AC) is to protect and preserve areas of the county which are presently rural or agricultural in



character and use and are uniquely suited to agricultural use. Where urban development is permitted within the district, strict quality standards should be required.

The purpose of the proposed zoning district (Residential-6, or R-6) is to provide for a variety of single-family housing on small lots to meet market demands for smaller lot developments. It is also the intent of this district to balance higher densities with common open space.


The applicant has stated they plan to create three (3) single family lots facing Barnhart Dr. and six (6) single family attached lots facing Minna Place.

An applicant is not limited by their stated use of the subject property. If rezoned, the applicant could establish any use allowed in the R-6 district subject to compliance with all required standards. See <u>Article 3-Exhibit 5 - Use Table</u> for the full range of land uses permitted "by right", via conditional use approval, or via special exception approval.

# III. COMPATIBILITY WITH THE 2040 COMPREHENSIVE PLAN

The Sumter 2040 Comprehensive Plan shows that the property is in the Priority Investment Area, specifically the Priority Commercial / Mixed Use Areas.

Priority Investment Planning Areas are identified within all major planning areas identified by the Sumter 2040 Comprehensive Plan, and should be considered as an overlay to the underlying Planning Area it is located in. The goal of the Priority Investment Planning Area is to



more acutely identify, direct, and concentrate on new development opportunities.

Priority Commercial and Mixed-use areas or nodes are identified on the map to direct future, high quality commercial and residential mixed-use development. The areas include anticipated green fields and established locations expected to redevelop with higher and better uses over time. New priority locations are designated for protection against undesirable uses such as industrial, automotive repair, or uses primarily engaged in outdoor storage. These locations encourage both destination retail commercial uses and neighborhood commercial uses as appropriate. Design, layout, impact on adjacent properties, landscaping, and architecture all play a vital role in determining context viability.

The request to rezone this property from AC to R-6 is in general alignment with the 2040 Plan.

#### IV. TRANSPORTATION REVIEW

The site has direct frontage onto Camden Hwy (US-521), Minna Pl. and Barnhardt Dr. Camden Hwy. and Minna Pl. are SCDOT owned/maintained roadways. The segment of Camden Hwy. directly in front of the subject property is a paved 5-lane section (2 travel lanes in each direction and a center median/turn lane) that is functionally classified as a principle arterial roadway. The segment of Minna Pl. directly in front of the subject property is a paved 2-lane section of roadway functionally classified as a local roadway. The segment of Barnhardt Dr. directly in front of the

subject property is owned and maintained by the City of Sumter, is a paved 2-lane section of roadway, and is functionally classified as a local road. Average annual daily trips in 2024 for each road segment are outlined below:

- Camden Hwy. 21,500 Station ID# 43-0226
- Minna Pl. < 500 Urban SDK Estimate
- Barnhardt Dr. No data available

All site development will have its transportation impacts fully evaluated at the time of site plan approval.

#### V. STAFF RECOMMENDATION

Staff recommends <u>approval</u> of this request. Increasing residential density on this property is in alignment with the Sumter 2040 Comprehensive plan. Further, infrastructure to serve potential new lots on the subject property is in place along Barnhart Dr.

## VII. PLANNING COMMISSION – June 25, 2025

The Sumter City – County Planning Commission at its meeting on Wednesday, June 25, 2025, voted unanimously to recommend approval of this request to rezone two parcels (TMS#s 202-00-03-014 & 202-00-03-021) totaling of +/- 1.85-acres in area from Agricultural Conservation (AC) to Residentrial-6 (R-6). The property is located at 1445 Camden Hwy. and is represented by TMS#'s 202-00-03-014 & 202-00-03-021.
