

ORDINANCE NUMBER 2905

**AN ORDINANCE AUTHORIZING THE SALE OF A CERTAIN CITY-OWNED
PARCEL OF LAND LOCATED AT 703 BROAD STREET, 846 LIBERTY
STREET, 1015 SOUTH MAIN STREET, AND 503 SOUTH HARVIN STREET
IN THE CITY OF SUMTER, SOUTH CAROLINA**

WHEREAS, the City of Sumter (the "City") currently owns a parcel of land located at 703 Broad Street, 846 Liberty Street, 1015 South Main Street, and 503 South Harvin Street, shown on Tax Map Numbers 229-07-03-012, 228-16-02-011, 226-05-02-049, and 250-08-02-036 (the Property); and

WHEREAS, the City Council of the City of Sumter (the "Council") has determined, as a fact and after appropriate investigation, that the City does not need the Property for any public purpose; and

WHEREAS, the Council has therefore determined to authorize the sale of the Property and to authorize the City Manager to carry out such sale and the authorizations contained in this Ordinance.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SUMTER, SOUTH CAROLINA, AT ITS REGULAR MEETING DULY ASSEMBLED AND BY THE AUTHORITY THEREOF:

1. That the City is hereby authorized to sell the subject parcel of land located at 703 Broad Street, 846 Liberty Street, 1015 South Main Street, and 503 South Harvin Street in the City of Sumter, South Carolina as described above.
2. That the City Manager be and is hereby authorized to negotiate, execute, and deliver all necessary deeds, agreements, papers, instruments, certificates, and other documents as may be necessary to carry out such sale and the authorizations contained in this Ordinance.
