

**RESOLUTION NUMBER 1015**

**A RESOLUTION APPROVING THE ENTRY OF A  
PURCHASE CONTRACT IN EXCESS OF \$100,000  
(SISTER WIMBERLY PLAYGROUND AT SWAN LAKE – PLAYGROUND EQUIPMENT PROJECT)**

**WHEREAS**, the City Council (the “Council”) of the City of Sumter, South Carolina (the “City”), has enacted an Ordinance entitled “An Ordinance Establishing Procurement Procedures for the City of Sumter, South Carolina” (the “Purchasing Ordinance”);

**WHEREAS**, pursuant to the Purchasing Ordinance, the Council must approve by resolution any purchase contract subject to the Purchasing Ordinance that exceeds \$100,000.00; and

**WHEREAS**, the Council has been presented with a request to approve a purchase contract (the “Contract”) in excess of \$100,000.00;

**NOW, THEREFORE**, be it resolved as follows:

**Section 1.** The Council hereby approves the Contract for the supplies, services, equipment, or construction identified below:

<b>SUBJECT:</b>	Sister Wimberly Playground at Swan Lake – Playground Equipment Project
<b>CONTRACTOR/VENDOR</b>	Great Southern Recreation Murfreesboro, Tennessee
<b>PRICE:</b>	\$1,400,846.92 (Funding Sources: State Grant Funds, Capital Projects Penny Sales Tax, Local Hospitality Fund, and Private Sector Funds)
<b>METHOD:</b>	Requests for Proposals (Purchasing Ordinance, Section II.C.); Supporting materials are attached.

**Section 2.** The City Manager is hereby authorized to negotiate, execute, and deliver the Contract on behalf of the City in such form and with such additions, deletions, or modifications as he deems necessary or prudent.

SUBJECT: Sister Wimberly Playground: Playground Equipment

---

The Sister Wimberly Playground: Playground Equipment project will include the turnkey installation of nature-themed play structures and various independent play elements. The play areas will be ADA accessible, featuring a combination of poured-in-place rubber safety surfacing, synthetic turf surfacing, and engineered wood fiber surfacing.

A Request for Proposal (RFP #01-24/25) was developed and issued in accordance with the City of Sumter Procurement Guidelines to select a qualified playground contractor. Based on the evaluation and scoring criteria, Great Southern Recreation was identified as the highest-scoring and most responsive firm.

It is our recommendation that the City contract with Great Southern Recreation for the Sister Wimberly Playground: Playground Equipment in the amount of \$1,400,846.92.

5. Provide and install the rock substrate for the playground area.
6. Execute installation of all playground equipment and play features.
7. Install all fall-protection surfacing systems.
8. Conduct final inspection and punch list of equipment and surfacing to confirm compliance with ADA and ASTM standards.
