Annexation Staff Report (ANN-25-04)

I. THE REQUEST

Applicant/Owner:	Bradford Meadows, LLC
Request:	100% Petition Annexation Request +/- 2.33 Acres (Including ROW)
Address:	1445 Camden Hwy.
Present Use/Zoning:	Residential / Agricultural Conservation (AC)

II. BACKGROUND

The applicant is requesting annexation for +/- 2.33-acres of property with frontage on Camden Hwy., Minna Pl., and Barnhart Dr. The property includes 2 separate TMS#s 202-00-03-014 & 202-00-03-021 totaling 1.85-acres and +/- 0.48-acres of adjacent SCDOT right-of-way (ROW) on Camden Hwy. and Minna Pl. The total area for annexation, including adjacent street ROW, is +/- 2.33 -acres.


The property is directly contiguous to City of Sumter jurisdiction to the north, east, and west. The property qualifies for the 100% petition annexation method.

The applicant is requesting annexation in order to subdivide the property for future residential development. It is staff's understanding the area will be an



addition to the Bradford Meadows subdivision to the north, with lots directly accessing onto Barnhart Dr.

The property is currently within the boundaries of the County Agricultural Conservation (AC) zoning district. The applicant has submitted a request to rezone the property to Residential-6 (R-6). This request is being considered via the standard rezoning process with a resulting recommendation from the Planning Commission. City Council will consider the rezoning request after a final decision has been made on this annexation request



The property at TMS# 202-00-03-014 is described in the deed recorded at Deed Book 829, Pages 563-566 at the Sumter County Register of Deeds. The property at TMS# 202-00-03-021 is described in the deed recorded at Deed Book 782, Pages 1144-1146 at the Sumter County Register of Deeds. The property at TMS# 202-00-03-014 is shown on the plat recorded at Plat Book Z-10, Page 6 at the Sumter County Register of Deeds. No plats could be located for TMS# 202-00-03-021. This property is a small strip of former SCDOT right-of-way that was conveyed to the owners of the property at 1445 Camden Hwy. in 2002, as described in the deed referenced above.

III. FACTORS FOR CONSIDERATION

- 1. Land Use Compatibility: This annexation request is consistent with the Sumter 2040 Comprehensive Plan. The property is primarily influenced by the Priority Commercial/Mixed Planning Area. The land area being considered for annexation is the intended location for new residential development.
 - The Priority Commercial/Mixed-Use—
 The Priority Commercial/Mixed
 Use designation focuses on areas or
 nodes identified as future locations
 for high quality commercial and
 residential mixed-use development.
 Areas with this designation should
 be protected against undesirable
 uses such as industrial, automotive
 repair, or uses primarily engaged in
 outdoor storage. Destination retail
 uses and neighborhood commercial
 uses are encouraged within this
 designation, as appropriate. <u>Design</u>,



<u>layout</u>, impact on adjacent properties, <u>landscaping</u>, and <u>architecture all play a vital role</u> in determining context viability.

2. Fiscal Impacts: All annexations increase the costs of providing public services such as public safety, sanitation, and public utilities. Increased costs are mitigated in part through property tax revenues, a portion of which is allocated to the city. Public utility costs are mitigated through user service fees that go toward ongoing system maintenance, operations, and capital costs.

The land area being considered for annexation is the intended location of new residential development. It is staff understanding that access to any new lots established within this area will be from Barnhardt Dr., within the established Bradford Meadows Subdivision. Any fiscal impact resulting from this annexation is anticipated to be minimal.

- **3. Growth Management:** This annexation request is consistent with growth management principles for the reasons outlined below:
 - a. The subject property is located within an unincorporated area along a major thorough fare, with city jurisdiction already existing to the north along Camden Hwy. The Camden Hwy. corridor is seeing significant growth pressures at this time and city utilities to these are in close proximity to the property.
- 4. Public Utilities: The property is in close proximity to existing city water and sewer lines on Barnhardt Dr. Any development on the property anticipated to connect to the water and sewer lines constructed as part of the Bradford Meadows Subdivision. Any cost to provide water and/or sewer service to the property will be the responsibility of the applicant. City Public Services will make the final determination on the city's ability to provide service and/or the scope of the improvements required to provide service to the property.



IV. STAFF RECOMMENDATION

Staff recommends that the property be annexed into the city. Annexation of any specific parcel is not an endorsement, in advance of review, for any specific development project or pending rezoning request.




