Phase 1a pricing of the Opera House Renovation project will include a variety of items with the highlights being remaining interior demolition of Annex and Auditorium, sitework, site utilities, masonry, and structural components for the Annex/Connector Spine.

A Request for Proposal (RFP 02-21/22) package to select a CM-R was developed and issued according to the City of Sumter Procurement Guidelines with Hood Construction Company being the highest scoring firm.

Hood Construction's construction fee for construction services is 5% and the cost for this portion of the project is \$5,701,855.00.

It is our recommendation that we contract with Hood Construction for the Phase 1a construction of the Opera House Renovations in the amount of \$5,701,855.00.
