

**RESOLUTION NUMBER 1017**

**A RESOLUTION APPROVING THE ENTRY OF A  
PURCHASE CONTRACT IN EXCESS OF \$100,000  
(DOWNTOWN WATER IMPROVEMENTS 2025 PROJECT)**

**WHEREAS**, the City Council (the “Council”) of the City of Sumter, South Carolina (the “City”), has enacted an Ordinance entitled “An Ordinance Establishing Procurement Procedures for the City of Sumter, South Carolina” (the “Purchasing Ordinance”);

**WHEREAS**, pursuant to the Purchasing Ordinance, the Council must approve by resolution any purchase contract subject to the Purchasing Ordinance that exceeds \$100,000.00; and

**WHEREAS**, the Council has been presented with a request to approve a purchase contract (the “Contract”) in excess of \$100,000.00;

**NOW, THEREFORE**, be it resolved as follows:

**Section 1.** The Council hereby approves the Contract for the supplies, services, equipment, or construction identified below:

**Section 2.** The City Manager is hereby authorized to negotiate, execute, and deliver the Contract on behalf of the City in such form and with such additions, deletions, or modifications as he deems necessary or prudent.

A bid opening was held at 2:00 PM on Thursday, November 13, 2025, at the City Public Services Complex for the Downtown Water Improvements 2025 project. Bids received were as follows:

B&B Construction Co., Inc.	(Sumter, SC)	\$2,565,720.00
CBG Construction, Inc.	(Columbia, SC)	\$2,985,906.00
Lake Murray Utility Co.	(Prosperity, SC)	\$3,141,312.00

I certify the project was advertised in the South Carolina Business Opportunities online bid database, and the bid opening was performed in accordance with the city's procurement ordinance.

B&B Construction Co., Inc. was the low bidder with a bid of \$2,565,720. It is my opinion this bid is a reasonable price for the quantity and size of the water lines to be installed. It is recommended that the city offer a contract to B&B Construction Co., Inc. to construct the subject waterlines.

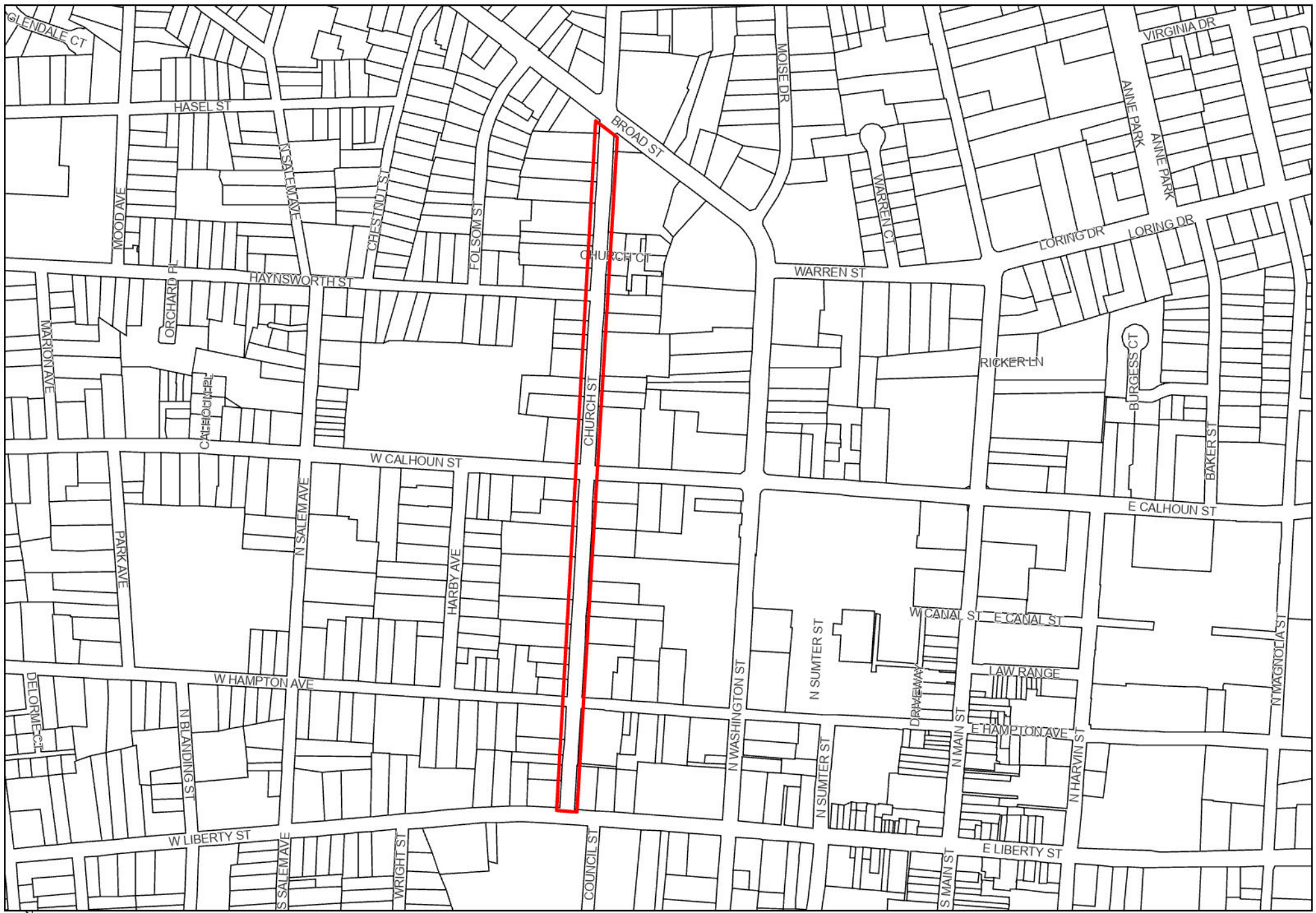

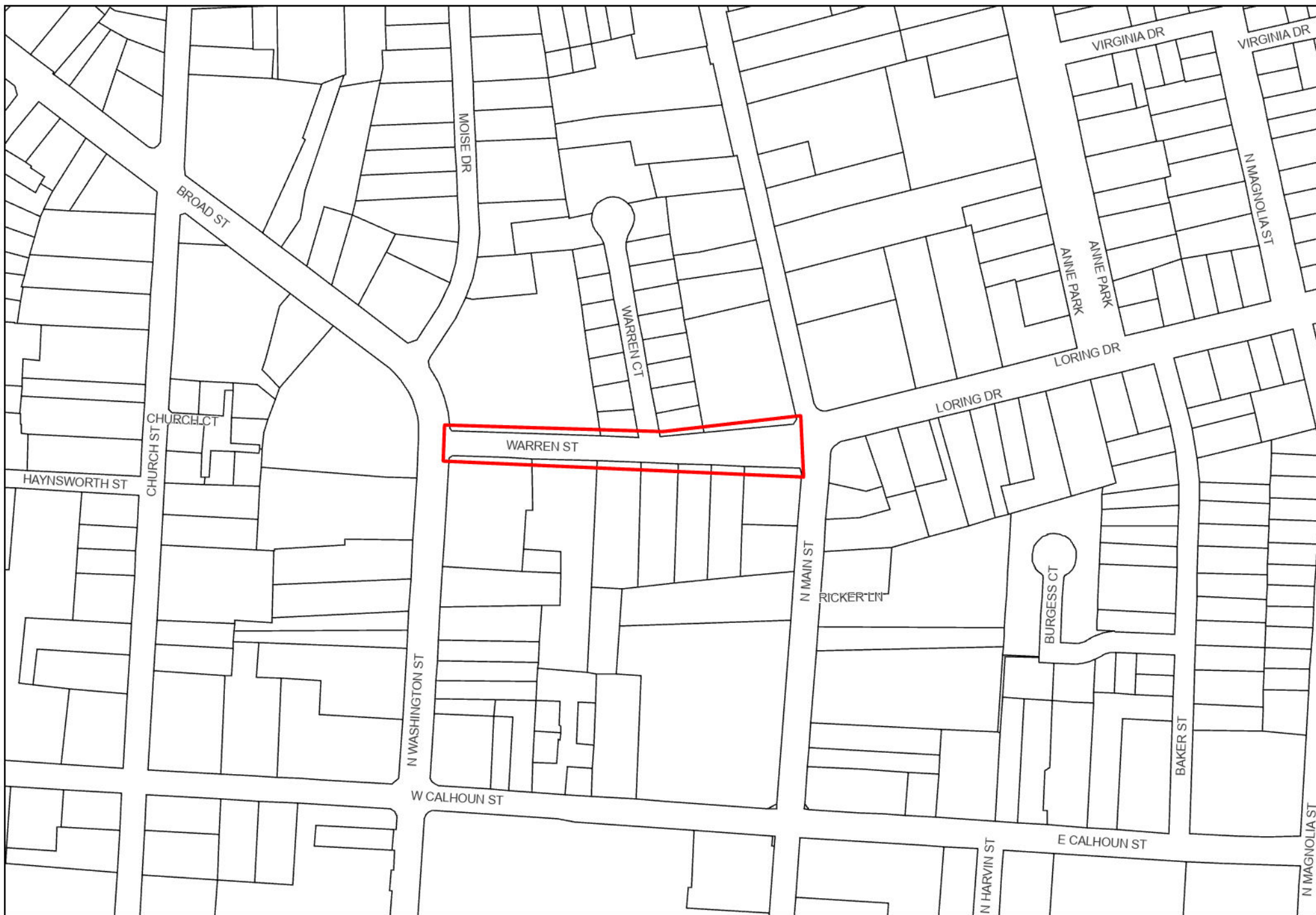

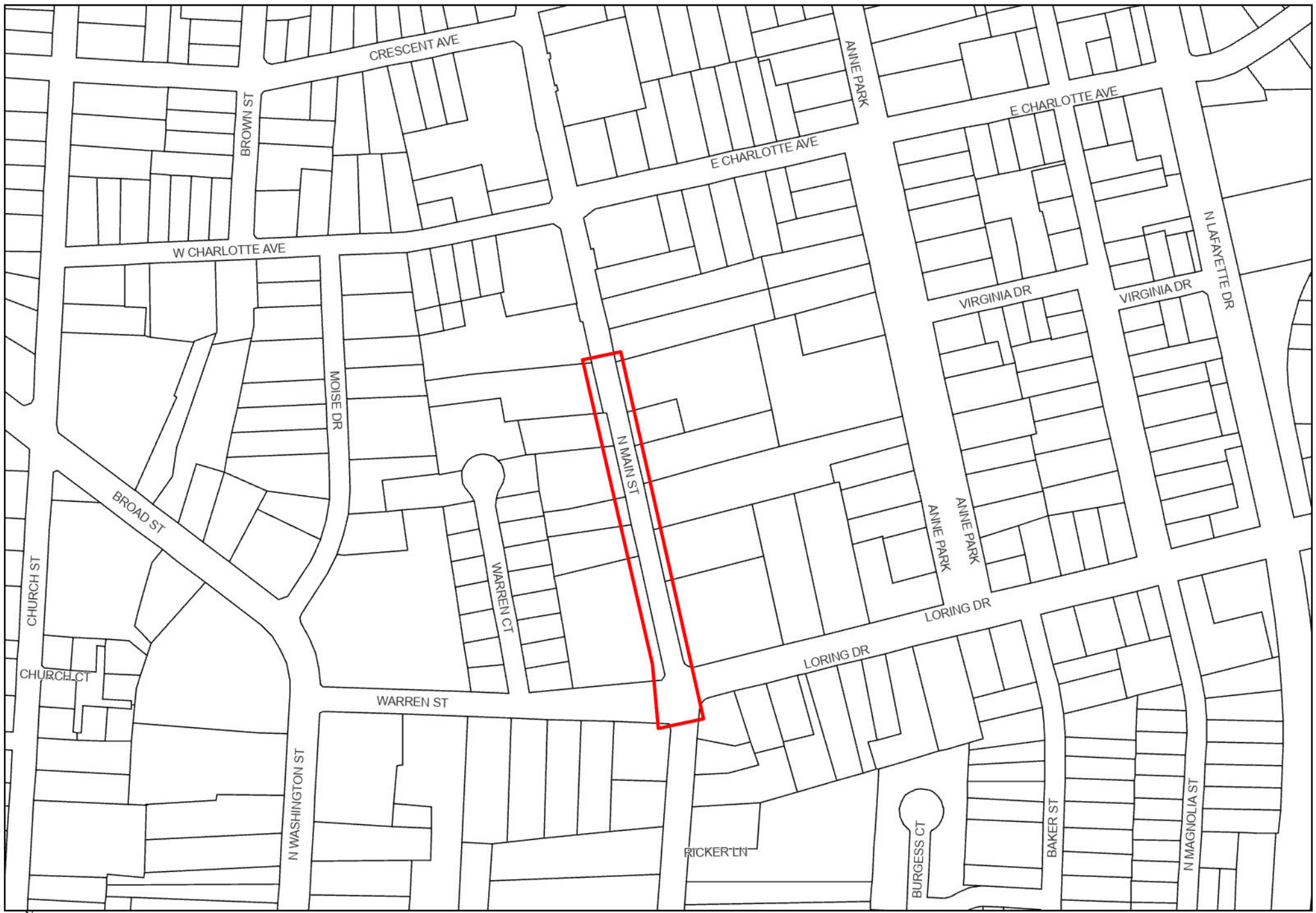
